Whereas, the draft of the Karnataka Co-operative Societies (Amendment) Rules, 2018 was published as required by sub-section (1) of section 129 of the Karnataka Co-operative Societies Act, 1959 (Karnataka Act 11 of 1959) in Notification No. CO 123 CLM 2016, dated: 22.01.2018 in Part-IVA of the Karnataka extra-ordinary Gazette, No.51, dated:22.01.2018 inviting objections and suggestions from all the persons likely to be affected thereby within fifteen days from the date of its publication in the official Gazette.

And whereas, the said Gazette was made available to the public on 22.01.2018.

And whereas, objections and suggestions received in this behalf have been considered by the State Government.

Now, therefore, in exercise of the powers conferred by section 129 of the Karnataka Co-operative Societies Act, 1959 (Karnataka Act 11 of 1959) the Government of Karnataka hereby makes the following rules further to amend the Karnataka Co-operative Societies Rules, 1960, namely:-

RULES

1. Title and commencement.- (1) These rules may be called the Karnataka Co-operative Societies (Amendment) Rules, 2018.

(2) They shall come into force from the date of their publication in the Official Gazette.

2. Amendment of rule 6.- In the Karnataka co-operative societies Rules, 1960 (hereinafter referred to as the said rules) in rule 6, in sub-rule (3) for clause (bb) the following shall be substituted, namely:-

"(bb) a treasury challan or demand draft in favour of the Registrar for having remitted the fee specified below:-

Area of operation of society	Amount of fees
------------------------------	----------------

(1)	Less than a taluk	Rs. 1,000/-
(2)	Taluk and above but less than a district	Rs. 2,500/-
(3)	District and above but less than region	Rs. 5,000/-
(4)	Region and above	Rs.12,500/-

"

3. Amendment of rule 17.- In rule 17 of the said rules, in sub-rule (2), in item (A), in sub-item (ii), in clause (a) after the proviso the following shall be inserted, namely:-

"Provided further that, the above proviso shall be applicable after a period of twenty four months from the date of commencement of the Karnataka Co-Operative Societies (Amendment) Rules, 2017."

4. Amendment of rule 18.- In rule 18 of the said rules, in sub-rule (1), in clause (c) and (d) the words and figures "the candidates shall be called upon to take written test in the ratio of 1:20 of the total notified posts, based on the percentage of marks obtained in the qualifying examination prescribed for the posts" shall be omitted.

5. Amendment of rule 20.- In rule 20 of the said rules, after sub-rule (3), the following shall be inserted, namely:-

"(3A) No decision shall be taken by the Board of the Karnataka State Co-operative Federation Limited, which contravenes the decision of the advisory committee."

6. Amendment of Annexure.- In the Annexure to the said rules, under the Heading,

E. THE KARNATAKA STATE CO-OPERATIVE APEX BANK LTD. for the words, "Additional Registrar of co-operative societies", the words, "Joint Registrar of co-operative societies" shall be substituted.
