## STATEMENT OF OBJECTS AND REASONS

Act 24 of 1984.- Under the Mysore Religious and Charitable Inams Abolition Act, 1955 the Karnataka (Sandur Area) Inams Abolition Act, 1976 the Karnataka Certain Inams Abolition Act, 1977 occupants of agricultural lands eligible for registration as occupants had to file applications within the specified time. The above Acts were amended by Karnataka Act 23 of 1981 and time was extended upto 30th June, 1981.

Several representations were received requesting for grant of further extension of time to file applications as quite a few small holders of Inam lands were not aware of the need to file such applications.

With a view to helping such holders of Inam lands, it is considered necessary to extend the time till 31st March 1984. An ordinance was promulgated to give effect to this decision. This Bill seeks to replace the said Ordinance.

Hence this Bill.

# THE KARNATAKA INAMS ABOLITION LAWS (AMENDMENT) ACT, 1984.

(Received the assent of the Governor on the Twenty-sixth day of April, 1984)

An Act further to amend the Mysore (Religious and Charitable) Inams Abolition Act, 1955, the Karnataka (Sandur Area) Inams Abolition Act, 1976 and the Karnataka Certain Inams Abolition Act 1977.

WHEREAS it is expedient further to amend the Mysore (Religious and Charitable) Inams Abolition Act, 1955, (Mysore Act 18 of 1955), the Karnataka (Sandur Area) Inams Abolition Act, 1976 (Karnataka Act 54 of 1976) and the Karnataka Certain Inams Abolition Act, 1977 (Karnataka Act 10 of 1978) for the purpose hereinafter appearing;

BE it enacted by the Karnataka State Legislature in the Thirty-fourth year of the Republic of India as follows:-

- **1. Short title and commencement.-** (1) This Act may be called the Karnataka Inams Abolition Laws (Amendment) Act, 1984.
- (2) It shall be deemed to have come into force on the twentieth day of December, 1983.
- **2.** Amendment of Mysore Act 18 of 1955.- In the Mysore (Religious and Charitable) Inams Abolition Act, 1955 (Mysore Act 18 of 1955), in sub-section (2) of section 9, in clause (a),-
- (1) in sub-clause (i), for the words and figures "30th June, 1981" the words and figures "31st March, 1984" shall be and shall be deemed always to have been substituted;
- (2) in sub-clause (ii), for the words and figures "30th June 1981" the words and figures "31st March, 1984" shall be and shall be deemed always to have been substituted;

- **5. Repeal and savings.-** (1) The Karnataka Inams Abolition Laws (Amendment) Ordinance, 1983 (Karnataka Ordinance 15 of 1983) is hereby repealed.
- (2) Notwithstanding such repeal anything done or any action taken under the Mysore Act 18 of 1955, Karnataka Act 54 of 1976 and the Karnataka Act 10 of 1978 as amended by the said Ordinance, shall be deemed to have been done or taken under the said Acts as amended by this Act.
