

**FOREST, ECOLOGY AND ENVIRONMENT SECRETARIAT  
NOTIFICATION**

**No. FEE 305 FEG 2012, Bengaluru, Dated : 26-08-2015.**

Whereas the draft of the following rules, further to amend the Karnataka Forest Department (Allotment of Government Quarters) Rules, 2010, which the Karnataka proposes to make in exercise of the powers conferred by rule 75 of the Karnataka Civil Services Rules and sub-section (1) of section 3 read with section 8 of the Karnataka State Civil Services Act, 1978 (Karnataka Act 14 of 1990) in Notification No. FEE 305 FEG 2012, dt. 20.11.2014 in part IV-A of the Karnataka gazette dated: 22-01-2015 inviting objections and suggestions from all the persons likely to be affected thereby within 15 days from the date of its publication in the official gazette..

And whereas the said gazette was made available the public on 22-01-2015 and whereas no objections received within the period specified above.

Now, therefore, in exercise of the powers conferred by sub-section (1) of section 3 read with section 8 of the Karnataka State Civil Services Act. 1978 (Karnataka Act 14 of 1990) the Government of Karnataka hereby makes the following rules, namely:-

**RULES**

**1. Title and Commencement.-** (1) These rules may be called the Karnataka Forest Department (Allotment of Government Quarters) (Amendment) Rules, 2014.

(2) They Shall come into force from the date of their publication in the Official Gazette.

**2. Amendment of rule 5.-** In rule 5 of the Karnataka Forest Department (Allotment of Government Quarters) Rules, 2010, (hereinafter referred to as the said rules),-

(1). in sub-rule(1), in the table,-

- (I) at serial number (i), for the words “Additional Principal Chief Conservator of Forests, Bengaluru”, the words and brackets” Additional Principal Chief Conservator of Forests (Head Quarters and Co-ordination) Bengaluru” shall be substituted;
- (II) at serial number (ii), for the words and brackets “Chief Conservator of Forests, (working plan), Bengaluru”, the words and brackets “Additional Principal Chief Conservator of Forests, (working plan)/Chief Conservator of Forests (working plan), Bengaluru” shall be substituted.
- (III) at serial number (iii), for the words “Conservator of Forests, Bengaluru Circle, Bengaluru”, the words and brackets “Chief Conservator of Forests (territorial), Bengaluru Circle” shall be substituted.

(2) in sub-rule (3), after the word “have”, the word “the” shall be inserted;

(3) in sub-rule (4), for the words “rent or penal rent”, the words “Licence Fee or Penal Licence Fee”, shall be substituted;

(4) in sub-rule (6), for the word “has”, the word “does” shall be substituted;

(5) after sub-rule 6), the following shall be inserted, namely:-

(7) In respect of Departmental Quarters Located at Bengaluru, before allotment of quarters to the applicants the Allotment Committee shall obtain prior approval of the Principal Chief Conservator of Forest and Head of Force”.

3. Amendment of rule 6.- In rule 6 of the said rules, the word “is” shall be omitted.

4.. Amendment of rule 8.- In rule 8 of the said rules in sub-rule (2),-

(a) for the word “Clause” the word” sub-rule” shall substituted; and

(b) after the words “received by him from his house” the following shall be inserted, at the end, namely:-

“not less than as specified in sub-rule(1)”

5. Amendment of rule 9.- In rule 9 of the said rule,-

(a) in sub-rule(1), in clause (v), for the words "Bengaluru Metropolitan City" the words" Bruhat Bengaluru Mahanagar Palike area" shall be substituted;

(b) in sub-rule(2) and (3) for the word "allotte" the word "allottee" shall be respectively be substituted;

(c) in sub-rule (4) and (5) for the words "any local or adjoining Municipality .or Municipal Corporation" the words " Bruhat Bengaluru Mahanagar Palike" shall respectively be substituted; and

(d) in sub-rule(6), for the word "rent", and for the figures "11", the words "Licence Fee" and the figures "13" shall respectively be substituted.

**6. Substitution of rule 18.-** For rule 18 of the said rules, the following shall be substituted, namely,-

**"18. Deposits.-** (1) The allottee shall credit in initial deposit with the Deputy Conservator of Forests, Bengaluru Urban Division, Bengaluru before occupation of the quarters at the following rates:-

(1) Group A Officers -Rs.5000/-

(2) Group B Officers -Rs.3000/-

(3) Group C Officers -Rs.2000/-

(4) Group D Officers -Rs.1000/-

2) The.initial deposlt specified in sub-rule(1) is.also.applicable to present occupants. The present occupant or allottee is required to deposit the differential amount within one month from the date of intimation with the Deputy Conservator of Forests, Bengaluru Urban Division, Bengaluru. The initial deposit is subject to refund without any interest upon it amount. after the allottee vacates the quarters in good conditions".

**7. Amendment of rule 22.-** In rule 22 of the said rules, in clause (b), after the words "his salary", the word "or" shall be inserted.

**8. Amendment of Annexure-1.-** In Annexure-1 to the said rules, in the Table, under the headings *category* of officers/officials and quarters No, for the entries relating to "Chief Conservator of Forests and above" and "Conservator of Forests and above" and corresponding entries relating thereto, the following shall respectively be substituted, namely.-

“Principal Chief Conservator of Forests Sankey - S-2 (Head of Forest Force)

Additional Principal Chief Conservator of Forests Sankey - S-1 and S-9

Chief Conservator of Forests/Conservator of Forests Sankey S-7, S-8 and S-10”

- 9. Amendment of Form-I.-** In Form-1 of the said rules, for serial No.14 and 15 and entries relating thereto, the following shall be substituted, namely:-

14	In case of female-applicant, whether unmarried, married or widow	
15	Mention the location of the quarters sought in the order of priority	1. 2.
16	Any other particulars which the applicant wishes to mention	

- 10. Amendment of Form-II.-** In Form-II of the said rules in column (4), for the words "Category to which the official belongs: SC/ST/General/Physically Handicapped" the words "Category to .which the official belongs: SC/ST/General/Physically Handicapped/ unmarried, married or widow in case of female applicant" shall be substituted.
